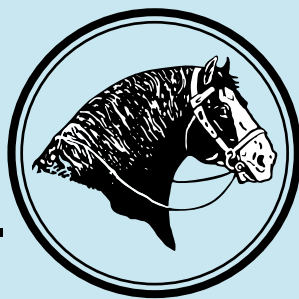

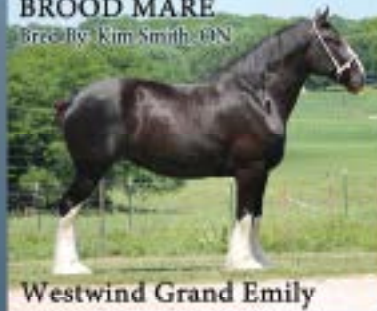

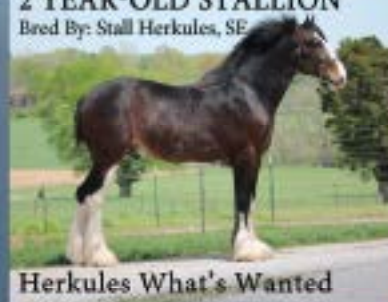

## *Did You Know?*

As of June 1, 2020, Several New Registration and Transfer Rules Are In Effect

- Breeders are responsible for registering their foals.
- Imported Shire Registrations must accompany ASHA registration requests (can be digital).
- It is the seller's responsibility to complete the transfer within 30 days of the sale date, to avoid penalties.
- To remain a member in good standing, all fees/services must be paid within 90 days.
- You can register/transfer/lease a horse from your smart phone through our DigitalHorses Registry.
- Stallion reports are due by January 31st for prior breeding season to avoid penalties.
- Ensuring proper transfer at the time of sale maintains the integrity of an accurate registry.

# RULES COMMITTEE REPORT

Greetings my fellow Shire friends:

I hope that you are each surviving 2020 with flying colors. It has been quite a year so far but the good news is, it is now on the downhill slide towards 2021. That is a hard concept to believe. We have seen so much this year in the world and at home that time seems to be irrelevant. It speaks true to the saying "Change is the only Constant". And with ASHA it is no different.

We have completed our first electronic voting and overall it was a huge success. All the By-Law changes were approved by the membership and all that information can be found here in the newsletter. I did want to address some concerns with the process as to help clear up any confused, worried, or unsure minds out there of this process.

The #1 priority is secrecy of the vote itself. ASHA used Election Buddy as the platform to conduct this election and future elections as well. Election Buddy is very easy to use and has lots of options to make voting smooth and trouble free. Karla Stoner, Charity Greenlee, and I all put in numerous hours to make sure this election went off without a hitch. The options that were chosen were to allow the administrators to see who had voted but NOT what or how they voted. This was done to protect the integrity of the ballot, but also to help ensure members got the ballots and to address any issues that might arise. We did have a couple of issues of emails not working, so those members were sent a paper ballot. There were a couple of members that did not receive the original email invitation to vote in the election, but were sent the correct information as to get their vote in and counted. As the election carried on, Election Buddy gave the option to send a reminder email to members that had not voted yet. From the list on Election Buddy we could also see who had not voted and start contacting some of these folks that we had personal connections to and reminded them to vote. We also used our Facebook page to do small video clips to remind ASHA members to check their emails including junk and spam folders as the invitation might have been treated as spam. A MailChimp email blast was also sent to the membership reminding of the vote coming to an end and to do their part and vote. Through these efforts we were able to get 16 more members to vote, well worth the effort I believe. I ask that anyone with more questions feel free to contact Karla, Charity, or myself with any questions you have concerning this vote.

We had 37% participate in this election. That is the most or right next to it for highest engagement in an election. Well done ASHA members! This process is very easy and I hope to see our participation numbers increase with each election. If you did not participate in this election, fear not there is another one coming this fall for Board of Director elections.

On that topic of elections, I want to encourage you as an ASHA member to consider running for the Board. We need new and (younger) blood to help carry on what our leaders have done over the years and continue to move ASHA forward. I know everyone is busy, I own two businesses not including have 9 draft horses to deal with; I mean love and devote my time too. I realize having a family with children makes time even shorter but I have a 12 year old and understand that very well. You don't have to be book smart or have served on boards before to be part of the governing body of this association. You just have to have a desire to see our wonderful Shire horse succeed in the future and the willingness to help it along, to consider running for the Board. If you have any questions on the Directors' elections and want other information, contact Karla Stoner.

Lastly, we need to address some issues with the Transferring of our Shires, otherwise known as selling horses. The office is continuing to have issues with incomplete transfer papers on horses. **It is the SELLERS responsibility to fill out the back of the Registration Certificate with all of the complete and correct information and send it into the office.** Too many transfers are coming in with little to no information, which causes a backlog and undo work for the office staff. As breeders and sellers of Shire horses we should take more pride in getting this process done correctly, as this is one of the few ways that ASHA makes money to help support the association and its members. The Rules committee has been tasked with looking into the Transfer process and seeing what can be done to make it an easier process for the paper version. I would be remiss without mentioning the easiest, convenient, and preferred way to transfer a horse is through our DigitalHorses Registry Program. This program is our registry and offers so many options that make user interface and interactions so smooth and effortless. You can simply log in and perform all actions and transactions in real time using a computer or your smart phone. You can contact the ASHA office if you have any questions concerning using this program. For those that still want to use the paper transfers for now, please completely fill out all pertinent information and send it back to the office. It is not the responsibility of the buyer, but that of the SELLER. Let's all do our part and help cut down on the confusion and extra work it is causing for the Association.

Until next time feel free to contact me with any questions and concerns. If I don't know the answer I will work to find it out.

# BOARD OF DIRECTORS ELECTIONS

The Nominating Committee is looking for candidates for five board of directors positions that will be vacated at the beginning of the 2021 first quarter board of directors teleconference in January. With the recent member approval of By-Law changes on board member terms and tenure, the 2020 election will be the first transition year for these changes. Three board members will be elected to three year terms and two board members will be elected to one year terms based on numbers of votes received. Board members elected for the one year terms may run again in 2021 and may run for two additional terms if they choose to do so.

Board members must become familiar with the current By-Laws of the association and accept the responsibility of participating in key decisions that affect the way the ASHA functions. They are expected to attend one face-to-face meeting once a year at their own expense, regardless of where in the U.S. it is held and be willing to take part in quarterly and special board teleconferences. Board members also serve on committees and volunteer for other duties as needed for the functioning of the ASHA and promotion of the Shire breed.

ASHA needs new people and fresh ideas to keep moving strongly into the future. If you love Shires, want to promote and preserve the breed and like working as a team with a diverse group of people, give serious consideration to volunteering your time and talents to the board for the good of the Shire breed and the membership.

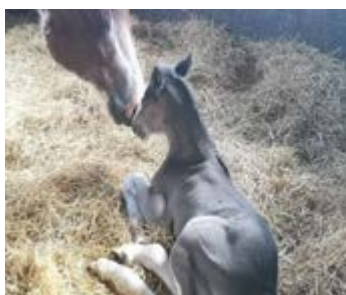

# Shire Horse History In America

## Chapter 7 - The American Horses

Please note: This work is an excerpt from a larger book with earlier installments in previous newsletters and is to be taken as the opinion of the author.

Fossil remains show clear evidence that horses are native to North America, but they died out until they were reintroduced by Spanish conquistadors in 1538 to Florida. Supposedly, some of the horses got loose and were so successful on the new continent that they proliferated and developed feral herds, spreading across what would become known as the United States. The American mustang is a direct descendent of these horses



and continues to be wild in several states. Taken from the twenty-fifth annual catalogue published in 1903, J.H. Truman was an importer, exporter and breeder of Shires, Percherons, Belgians, Suffolk and Hackney horses. "We have made more importations of Shires this season than any other firm, thereby insuring no culls and picked over stock on hand."

Wild horses were routinely captured and domesticated as riding horses. Like the early horses in England, they were small and sturdy. The early settlers in the Northeast part of the US simply took ownership of these horses and bred them for their own use. As cities such as New York and others required horse power, breeding operations became big business. Rhode Island became the horse breeding capital of the country. Small numbers of horses were imported from England and Holland during the 1600's to add size and quality. This mirrored what was going on in England at the same time. Many horses of that time came from a Thoroughbred background and were a descendent from the German High Almaine, which played a role in the evolution of the Shire as previously discussed.

As time passed, bigger equipment and the need to support even more people was required in the developing New World, thus the continual need for bigger horses. Big is a relative term; how big is big? Ships could not carry big horses until 1850 when new and bigger ships came into use. This would not have been problematic for young horses, but Keith Chivers reports that exports of English heavy horses to America were limited in those early days.

According to George E. Brown's article "Shire Horses: Their first introduction into America and the effect of their cross on the native stock" printed in the first issue of the American Shire Horse Stud Book in 1888, the first Shire imported to the US was in 1853. I have no reason to question this date, but there wasn't an official Shire registry for another twenty-five years in England. It is likely a majority of these horses were a Leicestershire type heavy horse which became the foundation for the American Shire in 1885. It is important to note that photographs and advertisements of imported horses labeled as Shires from the late 1800's are not consistent in appearance. This may be a reflection of traits related to specific geographical areas of England or the simpler answer is that these horses were not Shires. We will continue to explore this idea as we follow the development of the Shire registries in both countries.

During the heyday of draft imports, the horses traveled up the St Lawrence river and were unloaded on either the American or Canadian side. They were primarily breeding stock for farmers. Horses were then dispersed across the country by train, moving them further west. Minnesota, Wisconsin, Iowa, Illinois, and Indiana became the center of draft horse activity.

In some cases, English and Scottish horsemen came over to train, work, and breed these horses. Those men came mainly from tenant farm families who were not influenced by the large estate owners; their knowledge had been gained by working horses rather than showing and selling stud fees. Those guys played a major role in the development of the draft breeds in the US. This was especially true for the Clydes and Shires; they were not interested in the Lincolnshire type of horse that was fast becoming popular with members of the soon to be Shire Horse Society.

Many of the American importers were also English born and it was their business to know what the American buyer wanted and where to find the horses. Large Shire breeding operations never developed in the US. The importers supplied the market needs in the high-volume years of the 1870's and 80's.

The Breeders Gazette, a weekly agriculture and livestock publication owned by J.H.S. Johnstone, in Chicago, Illinois traced the movement of draft horses from 1881 to 1920. The Percheron was the first choice of heavy horse during this time with the Clyde second, and the Shire a close third and climbing. The Shire never made it to second place, but if we were to combine the two breeds which were very much alike and were the horses that made Great Britain the leading world power, they too would have been the American's first choice.

It was the Leicestershire type of Shire that was wanted by the Americans, the Scotchmen, and the commercial users of horses in England. As the Shire Horse Society focused on the Lincolnshire type, and breeders in England beginning to move in that direction, the importers simply ran out of marketable stock to buy. Remember, too, that the English were colonizing Australia in the same time frame and exporting Shires there as well.

In the report of the Shire Horse Societies London Show of 1890, Sanders Spencer said, "Another question which has received some considerable amount of attention, particularly in the American press, is that of the correct or best style, type, or character of the perfect Shire horse. Our American cousins have entered into the discussion with that verve and energy which have proved of such immense value to them in bringing nature into subjugation in their wonderful country; but have not they for the moment forgotten that the supplying of the American demands is not the only and chief point to be considered." This arrogant disrespect of other views brought the down fall of the breed. I think there must be something in the water that Shire people drink in the US that after 130 years they seem to think the same way. In future chapters I plan to take this approach head on.

The American farmers never wanted what we would now determine as tall horses. I have an old booklet from the Percheron Association in the early 1930's which named the 100 top Percheron stallions in order of correctness. One of those horses that was somewhere in the middle was praised for his overall quality, but his big fault was being too tall at 17-1h. Being tall was one of the faults attributed to Shires. In later years, big Shire stallions put on the western range mares found some favor. It was the importers that were the driving force in draft horse advancement in the US. They were much like car dealerships of today. Most would import and promote several different breeds. Their reputation and ability to stay in business was to keep their customers happy by providing what they wanted. The same men also served on the boards of the different breed associations to help promote their breeds. For example, Charles Burguss, who was a major importer of various draft breeds, served as Secretary of the American Shire Horse Association for 30 years.

In the next issue we will look more closely at these importers, some early breeders, and the forming of the American Shire Horse Association.

## WHEN A HOOF CONDITIONER IS REALLY NECESSARY

For generations, horse owners have seen the benefits of coating hooves with various substances for their protection and flexibility. Additionally, some old-time farriers have reported success in improving the hoof condition by abrading the coronet band to increase blood flow to the hoof.

We do not recommend this procedure today because of the chances of infection. However, the fundamental scientific principles they were trying to achieve, such as increasing blood flow, maintaining the internal moisture of the hoof wall, and repelling harmful substances, are as valid today as they were then.

Does your horse have soft, mushy hooves, dry, brittle, cracked feet, seedy toe, slow-growing hooves, structural damage, diseased hooves, or other problems? Is the current environment wet or dry, cold or hot? Knowing some basic biology and functions of the hoof will help influence your decision.

The hoof wall is the weight-bearing structure of the hoof and composed of thousands of tiny hollow fibers called tubules. These tubules run vertically from the coronary band and are cemented together with a protein substance called keratin. Layer upon layer of these tubules act like springs to absorb tremendous amounts of concussive force while retaining the necessary tensile strength.

The elasticity of these tubules and the hoof wall, in general, is dependent on its internal moisture content. Moisture is not merely water, but a mix of salts and electrolytes such as found in an I.V. solution. Without this essential moisture, the hoof wall would dry up, crack, become brittle, and generally fail at its job of a leaf spring/shock absorber. Too much moisture, on the other hand, can make a hoof too soft, mushy, and fail to absorb its concussive load. We now understand that a hoof conditioner should help maintain the natural moisture balance found within the hoof wall.

You may ask, "Why don't wild horses have hoof problems? Why do I need hoof protection if I don't have any hoof problems now?" The simple answer is in the domestication of the horse. The periople is a natural protein protective covering on the hoof wall that protects the feet against harmful contaminants. Thus the hoof makes its natural, delicate hoof sealant.

This natural sealant serves wild horses well, but it is lost in a domestic environment. It is inadvertently removed during the shoeing process when the hoof is trimmed, balanced, leveled, and shod. Domesticated horses can no longer roam free over miles of open space but are confined to smaller pastures, paddocks and stalls.

Now, with little or no natural sealant left and with the horn tubules opened from nail holes and rasping, hooves are exposed to higher concentrations of destructive uric acid and other contaminants. With the protective outer covering removed, the introduction of these agents into the hoof wall can lead to the breakdown of its protein, keratin. It is important to remember that because the hoof is protein, it is potentially biodegradable. Domesticated horses need a hoof conditioner that effectively replaces the periople.

Tiny openings on the hoof wall, from cracks and nail holes, are the main pathways for infection from bacteria, fungus, or other contaminants. Your grandfather and his grandfather before him intuitively used a type of hoof conditioner called pine tar. This product acted as a precursor to modern hoof conditioners as it helped to retain moisture in the hoof wall. Pine tar, unfortunately, had its drawbacks, but Grandpa was on the right track.

Later came various products that contained oils and petroleum-based ingredients that were used with limited success to coat the hoof and fill in the nail holes. Hoof conditioners that contain pine tar, salves, and oils usually stay fluid (wet) after they are applied and breakdown quickly when exposed to the environment. These dressings are usually sticky, and as such, attract contaminants instead of repelling them.

Their applications actually may be counter-productive because they can serve as a bacterial and fungal growth medium when they decay in a small crack or nail hole. These organisms produce enzymes and exotoxins that can break down collagen and protein in the hoof wall. If you do not get disease of the hoof wall, the least that can happen is that the hoof can get soft and punky at the nail holes. If this happens, your horse will throw more than its fair share of shoes.

Some of the modern-day hoof conditioners were a spin-off from the field of dentistry. For years, dentists have been coating children's teeth with synthetic sealants to keep them protected against tooth decay. Someone had the idea to try this same technique and apply it to horses' hooves. Others tried fingernail polish to provide a cosmetic shine. These synthetic coatings, such as methyl cellulose (fingernail polish) and urethane polymers, can outperform hoof oils, salves, and pine tar, but they have their limitations on hooves.

Synthetic sealants are impervious to moisture and do not allow the beneficial transpiration (water vapor transmission) to occur through the sole and frog where the foot needs to breathe. As a result, synthetic sealants can only be used on the hoof wall, not on the sole and frog, where serious protection is also needed.

The latest scientific methods have given us dual-action hoof conditioners that coat and protect the entire hoof capsule (horn, sole, and frog). They are not synthetic substances made from petroleum chemicals. They contain natural protein emulsions that help maintain the hoof's natural moisture balance. Unlike hoof oils, salves, and pine tar that remain fluid (a sticky liquid), the new modern coatings dry/cure to a battle-hardened finish, and last longer.

They are called "dual-action" hoof conditioners because they also contain the scientific ingredients known to provide the hoof with an antiseptic barrier against infection. Grandpa would have been proud to use these products had the technology existed in his day. Thanks, Grandpa, for getting us this far

## PROCEDURAL GUIDELINES FOR NOMINATIONS AND ELECTIONS

- I. The Nominating Committee shall be in place by the last day of March of the election year.
  - A. The Committee shall consist of two Board members and three members at large, all in good standing and eligible to vote as defined by the By-Laws.
  - B. Members of the Committee are NOT eligible to run as candidates.
- II. In the spring and /or summer bulletin shall be printed:
  - A. The nominating process.
  - B. The name of the chair and committee members with their postal and e-mail addresses and phone number(s).
- III. The final ballot shall be of sufficient number of candidates to fill the Board positions to be elected plus at least one.
  - A. Only members in good standing and eligible to serve as defined by the By-Laws are eligible to run.
  - B. The Nominating Committee may solicit volunteers to become candidates for the Board. Members wishing to run must contact a committee member IN WRITING by USPS or by e-mail by July 21.
  - C. By August 1, all candidates will receive a short form requesting the following information:

1. Name, address, phone number, and e-mail address.
  2. A statement of ability and commitment to attend membership and board meetings and do committee work should they be elected.
  3. A brief statement of strengths and contributions candidates can bring to the board (200 words max)
  4. Brief responses to a set of questions posed by the committee and/or regular members.
- D. The forms shall be completed and returned to the Chair postmarked or emailed no later than August 20. Forms postmarked or emailed after August 20 will not be considered.
1. The Chair shall forward copies of the completed forms to all committee members by August 30.
  2. All completed forms will be sent electronically to the Recording Secretary with the final slate.
- E. The Committee will confirm eligibility, review the written responses of all candidates and determine the final slate of candidates. The Chair will then notify all committee members, board members, and the ASHA Recording Secretary of the final slate by September 10.
- F. The final slate shall be printed up with the candidates' names, postal and email addresses, phone number(s) and personal response forms. A copy will be emailed or surface mailed with each ballot (Sect. IV).
- G. There shall be no maximum number of candidates.
- IV. The ballot shall be sent to all eligible voting members, as defined by the By-Laws, no later than October 31, either electronically via member email addresses on file in the office or by first class mail, if no email address is on file. No ASHA correspondence unrelated to the election shall be included in these mailings.
- A. The candidates shall be listed alphabetically, by last name, on the ballot.
  - B. Each first class mailed paper ballot shall include a small envelope clearly marked: 'BALLOT ONLY' - with a signature line and Do Not include any other ASHA correspondence.' and a larger return envelope with the address of the selected Notary Public as addressee and return address.
- V. The notices will also include the number of candidates to be elected, along with any other matters to be voted on by the membership and the deadline for voting or return of paper ballots. Paper ballot information will also include the date, location and time the count is to take place.
- A. Any paper ballots postmarked after the deadline date will not be counted.
  - B. One week after the deadline stated in the notice, the company conducting the electronic voting will forward the results of the voting to the ASHA Representative. On the same day, the notary shall present all surface mailed ballots, unopened, to the ASHA Representative and any other election clerks or assistants to verify all are sealed. Following this verification, the Notary and ASHA Representative will open all envelopes and remove the ballot envelope. Verification of voter eligibility will be accomplished by comparing the voter signature on the ballot envelope to the list of eligible members provided by the ASHA Secretary. The Notary will then remove the ballot from the ballot envelope in private and place it in one container and the ballot envelope in separate container.
  - C. When verification of surface mailed ballots is complete, the ASHA Representative and any assistants shall tabulate all valid ballots in the presence of the Notary.
  - D. Upon finishing and verifying the outcome of the surface mailed ballots, the ASHA Representative shall combine these results with those from the electronic voting and immediately notify the Nominating Committee Chair (if not the representative) and the President of the results.
    1. The Chair shall notify the committee, the candidates, and the board members of the results as soon as possible.
    2. The results must not be released to anyone else until December 21 or until all of the above have been notified, whichever ever comes first.
    3. In the case of a tie, the Chair will contact the candidates involved. If one wishes to withdraw, the other shall be the new board member. If both wish to continue, their names shall be placed in a container and a Notary Public shall draw the name of the winner.
  - F. The new board members shall be announced via email, website and in the winter bulletin.

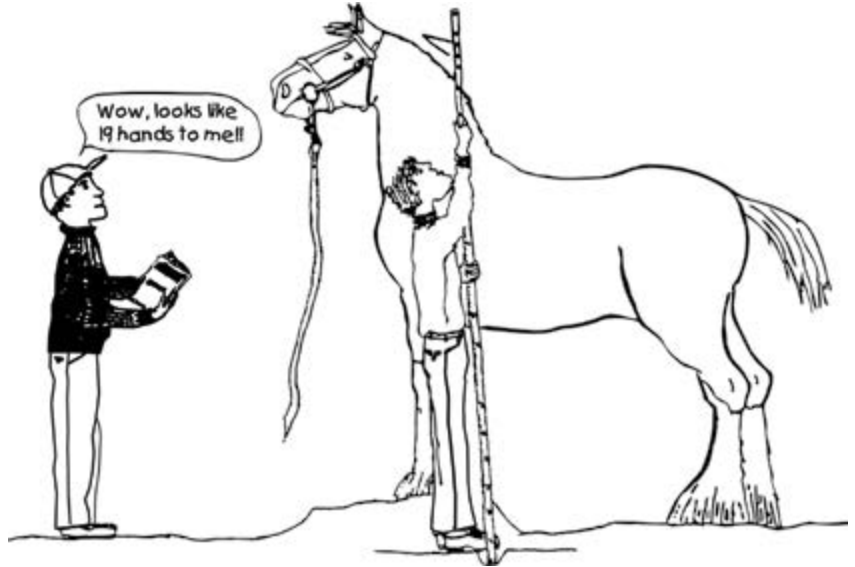
# HOW TALL REALLY IS YOUR SHIRE

“The first liar doesn’t stand a chance.” This little saying infers that the next liar can always top the first liar’s story. I don’t know if this applies to Shire owners or not; it could be that some simply do not know how to measure the height of a horse.

There are so many misleading comments and advertisements that it is nearly impossible to determine whom is/isn’t correctly representing their horses. Surely Shire owners do not have a lock on misrepresentation. Although it is found in nearly all draft breeds, we seem to have more than our share. I do believe that most of our incorrectness comes from lack of experience.

Many years ago a lady contacted me wishing to import a yearling filly. One of her requirements for such a purchase was that the filly had to mature to 18 hands, which was the height of two geldings she already owned. I explained that I could not make such a promise; even if we found one that looked to be that big someday, the price would undoubtedly be very high. Then as well as now horses, especially mares are rarely that tall. She was still insistent that any new purchase had to be as tall as her geldings; one of the geldings was 18 hands and the other was 18.1 hands. I finally sent a letter outlining the way I measured and asked her to measure her geldings the same way. She responded by saying that she had never measured her geldings but had been told how tall they were when she had purchased them. She did measure them at that time and found one to be 17 hands and the other 17.1 hands. I ended up getting her a filly that finished at 17.2 hands, at the regular price, and she couldn’t have been more pleased.



Sometime back, I heard about a big gelding being for sale so I called inquiring about the horse. Among other things, I was promised that he was 19 hands tall. I had some doubts so I pressed the issue, but was assured that he was that tall. I asked for, and received some pictures where the horse was out in the open with no points of reference to size the horse. Again I questioned the fact if he was truly that tall. Still assured of it, I started travel plans for the horse was well over a thousand miles away. In trying to schedule a time for my trip, a couple of weeks passed. I again called to arrange for a time to see him only to learn that he had been sold. I had been spared, for I later learned that the horse was 17.3 hands, not 19 hands.

Throughout the years the breed has become bigger in many cases, and the market seems to want bigger and bigger horses, but to simply say they are tall doesn’t make it so. Lying about the height hurts honest breeders and the breed in general. I know of buyers who were lied to and now want no part of Shires again.

Over the past 54 years I have measured literally thousands of horses. Some thirty plus years ago I obtained a walking cane that makes into a measuring stick. That cane has over three quarters of a million frequent flyer miles. In all of that time I have only measured one Shire that was 19.2 hands.

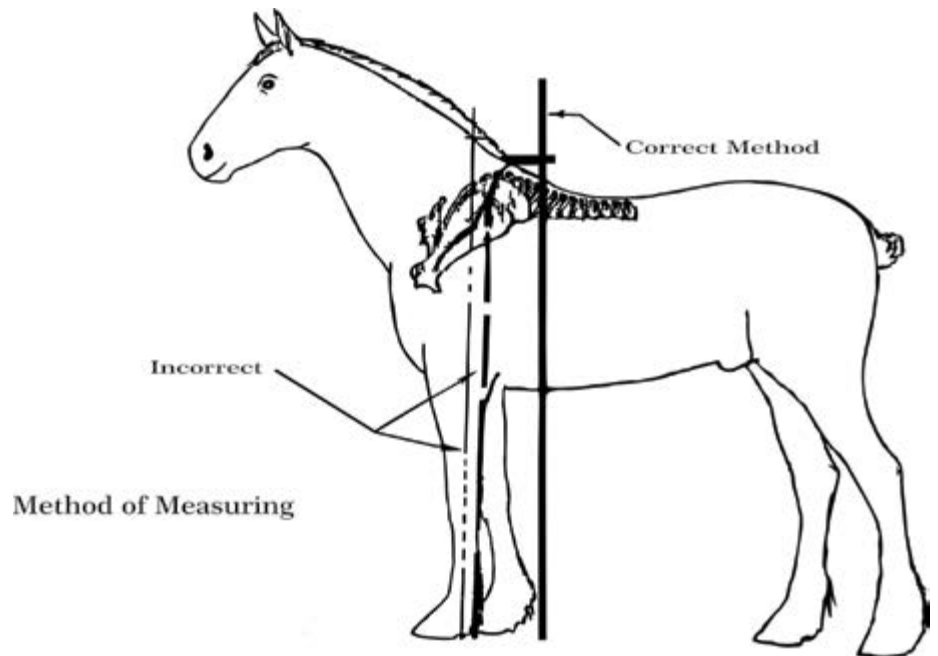
I have thought a lot about this situation and why it has become such a problem. There are those who just plain lie, and think they can get away with it. We have another group that was told the young horse they bought was by a 19 hand stallion and an 18 hand mare so the horse they bought would get that size. When the horse grew up they assumed it did, and never bothered to measure it. A third group came from the light horse world and their 17 hand Shire looked like a giant and must be at least 18 hands or more, again never measured. There is also another group that are perfectly honest but don’t know how to properly measure their horse.

The proper and universal method to determine the height of a horse is “the vertical distance from the ground to the top of the horses’ wither,” period. Where we seem to get into trouble is the procedure in which we measure that distance. Some people want to measure straight up the front leg, which is incorrect. Some want to measure with a string, or measuring tape, from the

ground, around the body and to the wither, again incorrect. This will add approximately 4 inches to a mature horse. Stallions with good sloping shoulders and a big crest running well down the back are very hard to determine the point of the wither, but with a little practice it can be done. I have learned even the placement of the hind legs as well as the front legs will make a difference. I have even heard it said that you should put your horse's head down in a bucket or something. I don't believe this either. It is true that the top of the wither is the same regardless of the placement of the head, but generally a horse with their head up will stand a little more posture correct or alert than one slumped over eating grain.

When measuring, stand the horse square on all four legs. You can find the top of the wither, which is the 4th or 5th thoracic vertebrae. You can usually see and feel the highest point. Allow the horse to move his head up and down at this time. After you have determined the right place, either physically or mentally mark the exact spot. Now stand your measuring stick straight up, not angled in any direction, and place a level bar from the upright stick to the top of the wither at the point you previously marked. Use a bubble level to make sure it is not slanting up or down. There are measuring sticks designed to accomplish this, and most have a built in leveling device. Refer to the figure for visual guide. As a side note, also be careful of those measuring tapes that claim to tell your horses weight. They can be very misleading. If you really want to know the weight of your horse, find a scale and weigh him. I believe that in most cases you will find that they don't weigh as much as you think.



If it is important to you to promote the height of your horse, it is important to do it correctly. If that 12 month old colt is only 15 hands he will never be much over 17 hands when fully grown, so don't fall for a snake oil sales pitch. You should feel no shame if your Shire doesn't weigh a ton and stand 18 hands tall, the percentage of Shires exceeding this is small. The Breed Standard adopted over 40 years ago in America states the average height of Shires to be 17.1 hands. While some breeders have bigger and taller stock, others aren't as big so the overall average height in the US hasn't changed much.

There is an old saying, "It takes a big dog to weigh a ton," it takes a big horse to be 19 hands, or for that matter 18 hands.





# FOAL DIARRHEA OR DIARRHEA HAPPENS

A majority of foals will exhibit diarrhea at some time within the first 2 months of life. In most cases, the diarrhea is mild, transient, not contagious to other foals and not life threatening. However, in some instances, diarrhea can be contagious, severe and possibly even fatal.

Non-infectious diarrhea occurs most commonly during the first 2 weeks after birth as foals are beginning to establish their normal complement of intestinal microorganisms. This transient physiologic condition has been termed 'foal heat diarrhea' because it occurs at approximately the same time as the mare is first returning to estrus after foaling. Contrary to popular belief, foal heat diarrhea is not associated with hormonal changes in the mare or alterations in the composition of her milk. The condition occurs after the foal begins to eat solid food and ingests fecal material from the mare. Ingestion of feces, termed coprophagy, is a natural or instinctual behavior for a young foal and is how the normal gut flora and fauna is acquired.

The typical foal heat diarrhea is self-limiting and not contagious. Affected foals are bright and alert, continue to nurse and do not have a fever. Additional causes of non-infectious diarrhea in foals include lactose intolerance, over feeding, ingestion of sand, and administration of certain antibiotics.

The most common infectious cause of diarrhea in foals is rotavirus. This viral disease is highly contagious and often affects multiple foals in a barn or on a farm. The incubation period, or time interval between exposure and onset of clinical signs, is between 3 and 10 days. Affected foals may have a mild to moderate fever and are often depressed and not nursing well. Foals with rotavirus may become dehydrated rapidly due to decreased fluid intake (i.e. not nursing) and increased fluid output (i.e. watery stool). A clinical diagnosis can be confirmed by detecting the presence of virus in feces submitted to a diagnostic laboratory.

The incidence of rotavirus infection can be reduced on farms by isolating affected foals, strict attention to hygiene and disinfecting stalls and equipment. Mares may be vaccinated at 8, 9 and 10 months of pregnancy to increase antibody levels in colostrum for passive transfer to the newborn foal.

Other infectious causes of diarrhea in foals include salmonella, E. coli, clostridium, rhodococcus and other bacterial or viral organisms.

Management strategies for foals with diarrhea depend on severity, duration and cause. In general, administration of fluids is one of the most important components of medical therapy. Mild cases may be treated safely and effectively with an oral fluid and electrolyte solution, while more severe cases may require intravenous fluid administration. Intestinal protectants such as bismuth subsalicylate (Pep-to-Bismolâ), intestinal adsorbents (i.e. Bio-Sponge™) and probiotics are commonly used. Other therapies that may be recommended by a veterinarian include anti-ulcer medications, analgesics, antibiotics and/or intravenous plasma administration.

In summary, non-infectious causes of diarrhea often resolve spontaneously or with minimal medical intervention. Foals that are febrile, depressed, not nursing and/or have a profuse watery or bloody diarrhea should be examined and treated by a veterinarian. Appropriate diagnostic tests, management decisions and medical therapy may be critical in preventing spread of infectious organisms or limiting the severity of illness in affected foals.
