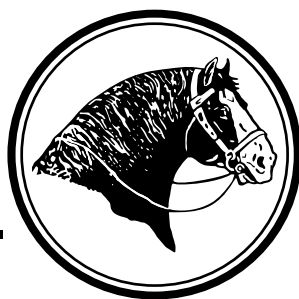

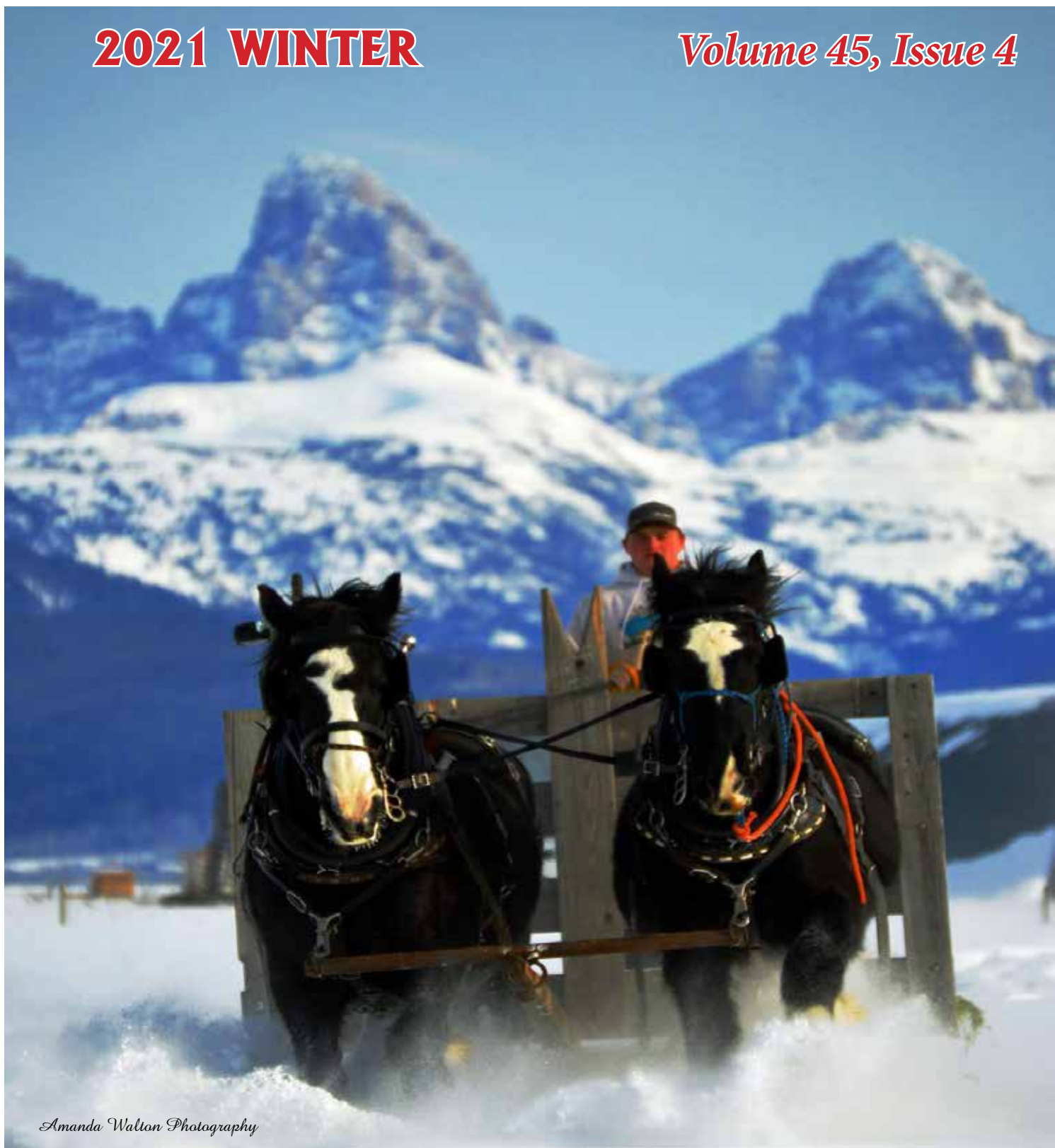

# ANAPLASMOSIS

We had heard of Anaplasmosis, but in our part of Virginia, we have luckily never had a case in our herd, that we had to treat. Unfortunately we had a crash course, when our 3 year old stallion, Gunner spiked a 106 degree temperature Wednesday evening, the day before the Keystone International Livestock Exposition in Harrisburg, PA was to begin on Thursday. Gunner had been in PA being fitted for the show, so luckily he was already at the show complex, and the on-call state veterinarian did a quick evaluation, and with a dose of banamine on board, Gunner was headed 1.5 hours east to the New Bolton Center, a part of the University of Pennsylvania's Veterinarian School.

Anaplasmosis is a common tick-transmitted disease of horses, caused by the bacterium, *Anaplasma phagocytophilum*. Deer ticks (*Ixodes scapularis*) and the Western black-legged ticks transmits this bacterium to horses as well as other animal species, including humans. Once bitten by an infected tick, the horse generally starts to show early signs of the disease within 3-14 days. During the early stages of the disease, the horse develops a very high fever of 103 to 106°F. Other clinical signs include reluctance to move, depression, reduced appetite, occasional staggering, and mild edema in the lower limbs.



After Gunner's 1.5 hour trip, he arrived about 10:30 PM and his temperature was 101.5, and it never went above that while at New Bolton, with no other Banamine given. Because Gunner had a somewhat decreased appetite, a spiked fever, and slight swelling in his rear legs, along with a low white blood cell count, New Bolton was also suspecting Anaplasmosis. They immediately started him on Oxytetracycline, a powerful antibiotic administered intravenously. They ran all the usual tests to eliminate any other possible diseases, and they all were negative. The test results for Anaplasmosis took several days and after spending a day and a half getting antibiotics and tearing out 2 IVs, they determined he was feeling good enough to leave. So we went and picked him up on Friday and returned back to the expo complex with him in quarantine, just for protection of other horses.

Several days after arriving back home in Virginia, New Bolton called with negative results for Anaplasmosis, which they said is possible, due to his quick treatment. Beings he responded so well on the Oxytetracycline, their final determination was a tick-borne disease. Gunner made a complete recovery.

Because tick borne diseases are becoming more and more common, most horses have been bitten and have antibodies for the bacterium and you never know that they have been infected.

The severity of signs varies with the age of the animal and duration of the illness. Signs may be mild. Horses less than 1 year old may have a fever only; horses 1 to 3 years old develop fever, depression, mild limb swelling, and lack of coordination. Adults exhibit the characteristic signs of fever, poor appetite, depression, reluctance to move, limb swelling, and jaundice. Fever is highest during the first 1 to 3 days of infection, but may last for 6 to 12 days. Signs become more severe over several days. Any existing infection (such as a leg wound or respiratory infection) can be made worse. The infectious agent can be found in white blood cells 3-5 days after infection. DNA and antibody tests can also detect the disease.

Prognosis is excellent if the disease is recognized early and treatment is initiated. In more severe cases where neurologic signs develop additional treatment may be needed and permanent injury may occur due to incoordination/ataxia. Fatality is rarely reported due to this disease unless secondary complications occur.

# Shire Horse History In America

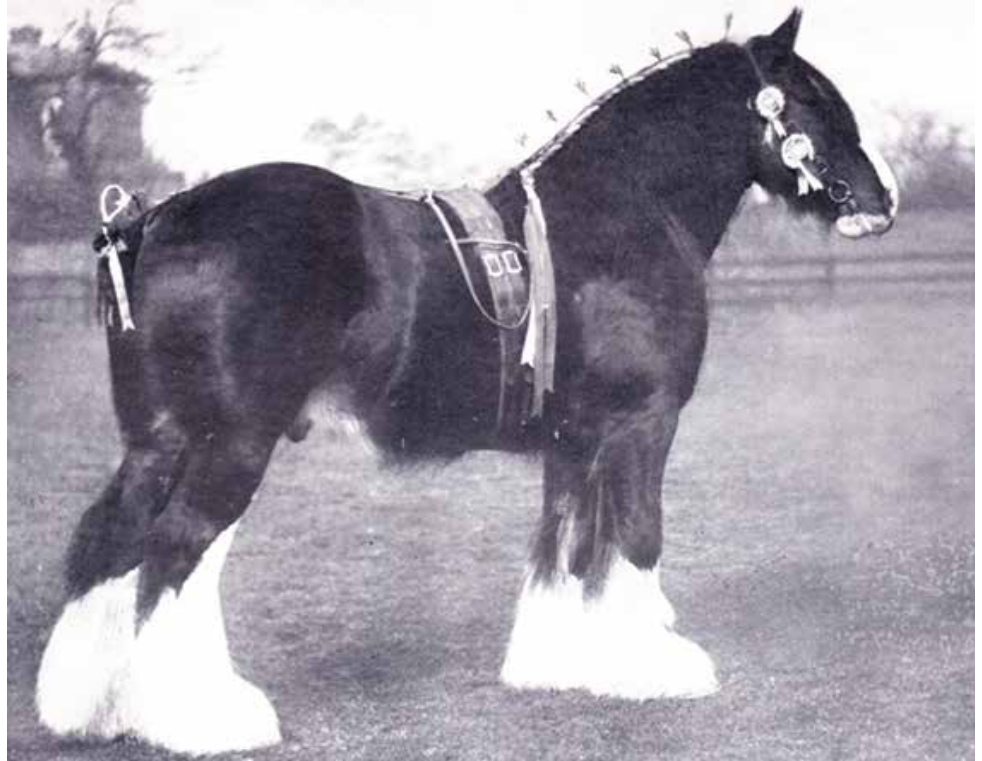

## Chapter 13

*Please note: This work is an excerpt from a larger book with earlier installments in previous newsletters and is to be taken as the opinion of the author.*

The two world wars had a devastating effect on England that impacted every phase of life and raising Shire horses was no exception. Not only were a lot of horses lost, following WW I many of the good Shire bloodlines were gone as well. The large estates were gone and with them went the landed gentry with their huge breeding operations that had dominated the show ring. The big heavy legged Shire they admired, and the Shire Horse Society had aspired to, was much diminished.

For the first time, small tenant farmers were able to serve on the Shire Horse Society council. There was still a real need for good draft horses, but the available stock to rebuild was in short supply. The people that used draft horses wanted no part of the Lincolnshire type Shire. They were looking for more of the Leicestershire type, which was also sought after by the few American buyers. Most of the farmers came from generations of breeders who had experience and knowledge with this type. However, the genetic pool was simply not broad enough to make the needed changes. It was around this time that the SHS most likely adopted a set of breed standards, a move to unite breeders in an effort to develop quality animals from the surviving horses. I have spoken with several members of the current SHS and there does not seem to be an exact date or language of the original breed adoption.



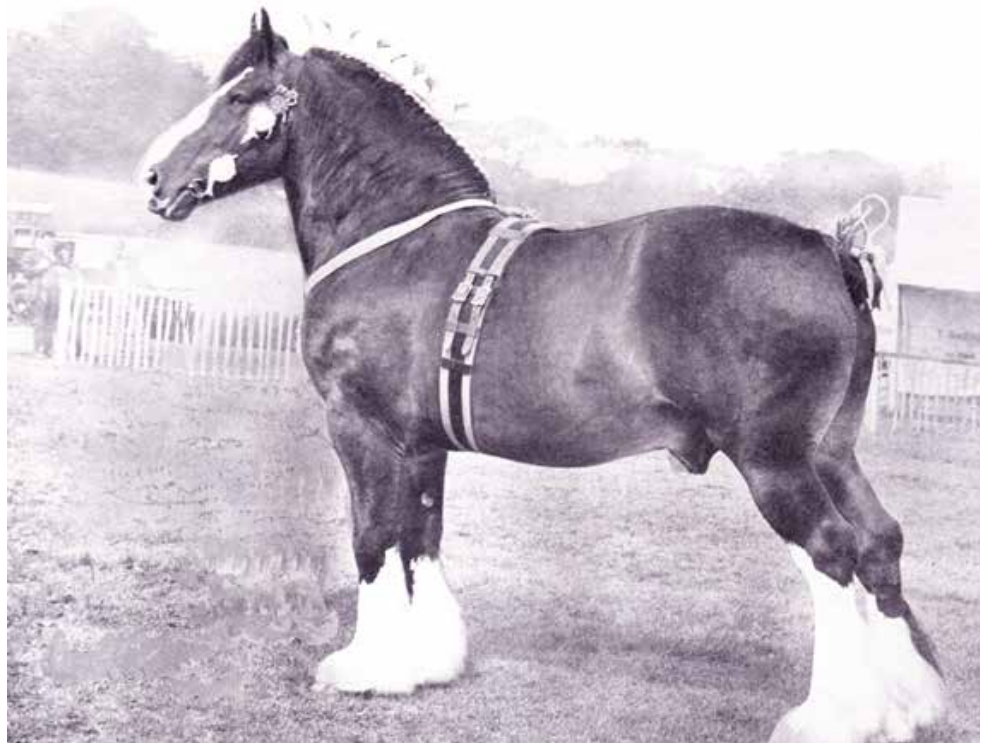

There had always been movement of horses between England and Scotland: through purchases, sharing studs and, if you go back far enough in history, outright reeving. Shires and Clydesdales were basically the same breed for years, with the foundation of the Clyde coming from England. After the registries of the Clydesdales and Shires were formed, their respective societies did not openly interchange horses. Many stories persist that this rule was violated from time to time. We could fill this book with those stories, but it seems clear that their Clyde cousins had some of the genetic traits needed to help rebuild the Shire breed, so in the 1930's horses crossed the border routinely regardless of registration and many ended up in the Shire Horse Society Stud Book as well as their offspring

For example, Phillip Moss told me the story of his uncle taking a mare to Tom Forshaw in the 1930's to be serviced. The Forshaw family was highly respected by members of the SHS as well as estate owners and the majority of the breeders throughout the country. The family began keeping Shires in 1863 and was recognized for generations as good and knowledgeable horsemen, and books have been written about their accomplishments. This is not a Forshaw story, but they represent the Shire activity in those days. They were breeders; they bought and sold horses, exported and were known for their stud service. At one time they had 700 stallions throughout England and Wales. They were standing about 75 studs at the beginning of the war, but most went to slaughter because there simply wasn't enough food available to keep them fed.

It seems when Phillip's uncle arrived at the Forshaw stable, he saw twenty studs in box stalls lined up in a row. Each stall had Dutch double doors with the top half open to see in. He was told to choose which stallion he wanted to use; the price was the same for all. The entire door was closed on one stall and he was told that horse was sick and not available. After the mare had been serviced he was invited in the house for a cup of tea before heading home. As he was leaving, the hired man was sent to help him get the mare. They passed the closed stall door so he asked the man how the sick stallion was doing. The hired man said there wasn't a sick horse and opened the door to show him. There in front of him was a fine Clydesdale stallion.

It was apparent new blood was needed, and as time passed Clyde stallions were more blatantly brought south. After all, both breeds came from a common ancestry. At the same time, registered Shire mares traveled north and both breeds were improved. This action put the Shire registry in a tight spot, but the need to rebuild the breed was more important than the paperwork. The very existence of the breed was at stake so they took sort of a blind eye to the situation. After all, the improvement of the breed was a worthy cause and surely not worth a big fight. Many breeders felt if the breed were to fail, at least they would fail with quality.

In an effort to advance that approach legitimately, the SHS adopted a grading up program in 1940. This allowed Clydesdale and nonregistered mares to be bred to a Shire stallion and the female offspring identified with an A registration number in the studbook. If that mare was then put to a registered Shire stud, a filly offspring would then be upgraded to a B number. The next generation mare would have a regular full number and be indistinguishable in the registry. A stud colt could only be registered as a Shire if both parents were registered as full Shire. This program has been slightly changed over the years but is still used today. In the hands of a knowledgeable breeder, it provides a path for added genes and a better horse. This is a slow process that was much too slow to work on a dying breed, so Clyde stallions continued to be used by a few breeders.

By the 1940's the English economy had rebuilt itself both commercially and agriculturally with tractors and freight trucks. They were almost forced into it simply because there were not enough horses left to sustain industry so they had to turn to a means that could be replicated more efficiently. Draft horses were no longer in demand as working animals and had instead become a hobby and tradition. According to Keith Chivers, in 1947 approximately 100,000 horses were put down and an equal number the following year.

One of the last bastions of the Shire were English breweries. The Whitbread Brewery is one of the most famous and had the most longevity. Founded by Samuel Whitbread in 1742 and, according to paintings done in the same time period, he relied on draft horses that would become known as Shires to pull beer wagons through London. John Oaksey's book *Pride of the Shires* published in 1979 profiles the grey Shires who were still being used at that time for promotional purposes.

In describing the origins of the Whitbread Shires, he said, "Although [Robert] Bakewell seldom actually sold his stallions, preferring to let them out for a season's round, there is no doubt that his efforts had far-reaching results. In 1774, for instance, 'a remarkable strong black horse' and 'a beautiful black horse...allowed to be the best ever shown in Scotland' were advertised in an Edinburgh paper to cover mares at a fee of fifteen shillings. One was said to be 'bred by Mr. Bakewell at Dishley in Leicestershire' and the other was 'the property of Mr. Robert Bakewell'. So, although there is to my knowledge no actual proof, it

seems a reasonable guess that in 1787, when George III visited the Chiswell Street Brewery, some of the eighty horses by whom, according to the London Chronicle, he and Queen Charlotte were so much impressed, may well have had Dishley blood in their veins.”

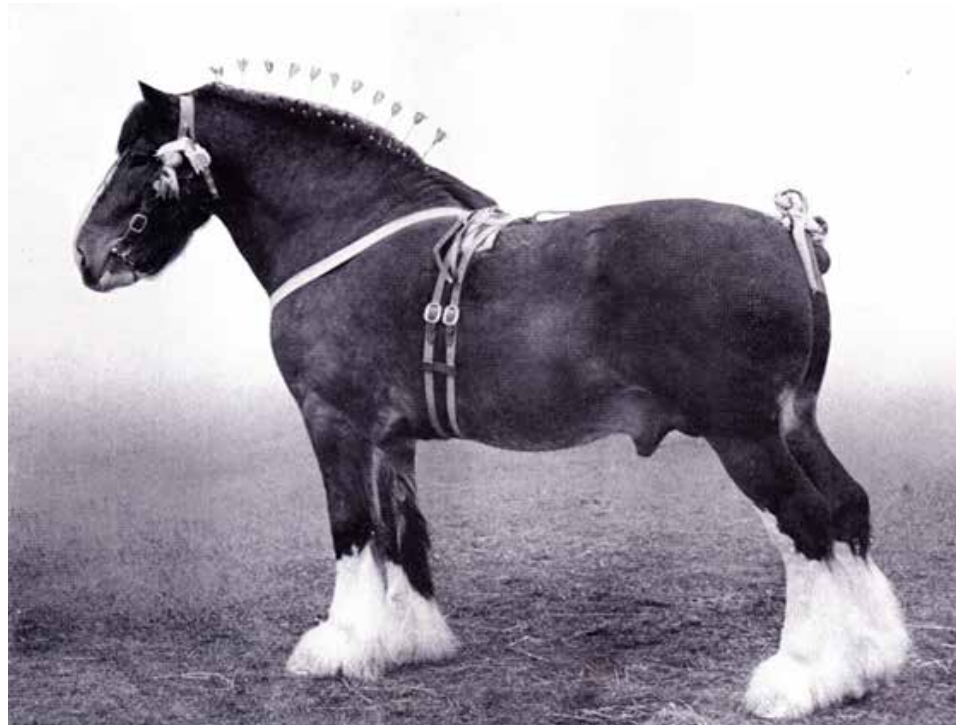
Remember that the draft horse referred to as Bakewell’s Black was based on the Leicestershire type horse crossed with Friesians and Samuel Whitbread was a contemporary of Robert Bakewell. The Whitbread family have continued to be avid horsemen in successive generations, buying, showing and breeding Shires. Brewers provided one of the few reliable markets left for Shires in the twentieth century.

Many dairy farmers maintained working horses; the two sort of make a good combination. This was true even in to the late 1900’s. A good friend of mine by the name of Allen Lees milked cows and delivered milk to families in Oldham with a Shire until 1989. A good horse was essential to his livelihood.

On our 1970 tour of England, with 45 American horsemen in attendance (discussed in more detail in the coming chapters), our first Shire farm stop was at Cole Ambrose near Ely, in the heart of the Fens. As we neared the farm we saw workers with one horse on tipcarts scattering manure. Cole Ambrose is one of the oldest and largest modern farming operations in England but was still using some horsepower. The English people have always been horse enthusiasts and love to admire them at shows and other horse events, but Shire numbers continued to decline. In 1958 there were only 5 stallions, and 24 mares registered with the Shire Horse Society.

In September of 1962, Albert G. Holland, who had been the secretary of the Shire

Horse Society since 1929, resigned. He continued to do the work, with no pay, until June of 1963 when Roy Bird was persuaded to be his replacement. Mr. Bird was the Secretary Manager of the East of England Agriculture Show at Peterborough at the same time the office was moved from London to that location. Roy was also the secretary for a number of small societies, so he understood that part of the job, but was totally unfamiliar with the Shire horse.

After Roy accepted the position, he told me one of the Shire council members said, “Don’t worry too much about this job, your biggest job will be to find a resting place for the Society.” Roy didn’t follow that advise. He made it plain the Shire horse and SHS were not going to fail during his watch. By coincidence, this is the exact time Ed Henken was putting the American Shire Horse Association back together.

We have looked at the history of this breed for over 2000 years, through the efforts of a vast number of people with many millions of horses being part of this process. At the beginning of the twentieth century Shires were exported to Germany, Russia, Australia, Canada, the United States and Argentina. None of the registries and few of the horses survived beyond the wars and mechanization. (MacEwan, 108) It is hard to grasp that there were less than 100 Shires registered in the world in 1958 and I think there may have actually been fewer. We were that close to losing the breed.

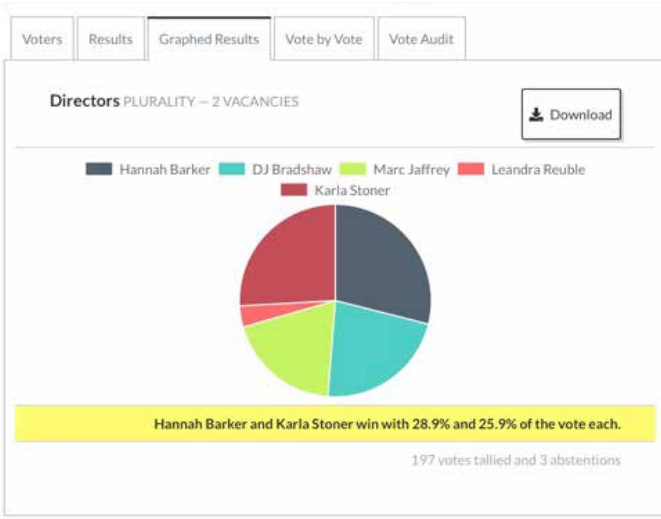

# Management of Retained Placentas

The placenta consists of the amnion, umbilical cord and chorioallantois. The amnion is a thin, transparent grey membrane that immediately surrounds the fetus. The umbilical cord connects the fetus to a thicker, velvety brick-red outer placental membrane or chorioallantois, that is attached to the uterus of the mare.

Separation of the placenta from the uterus begins prior to foaling and complete expulsion usually occurs within 30 minutes to 2 hours after foaling. Rupture of the umbilical cord after delivery of the foal causes collapse of the fetal placental blood vessels and subsequent shrinkage of the microscopic placental attachment sites. Uterine contractions post foaling in combination with traction applied to the outer placental membrane due to the weight of the amnion eventually results in release of the placenta from the uterus.

Retention of the placenta is one of the most common problems of the mare in the early postpartum period. A placenta is considered to be retained if it has not passed within 3 hours after foaling. The incidence increases following abortion, dystocia, obstetrical manipulations, cesarean surgery, induction of labor, placental infections, fescue toxicity and other factors. The percentage of broodmares that retain their placenta ranges from 2 to 10 %. Mares with a history of retained placenta have an increased risk of having another retained placenta in the future.

Mares may retain the entire outer placental membrane or only a portion of one horn tip following foaling. Detection of a retained placenta may not be obvious if only a portion of the placenta is retained within the uterus. The foaling attendant should examine the entire placenta once it has passed to determine if both horn tips are present. If the placenta is spread out in a 'Y' pattern, the tip of one horn will be noticeably thicker than the tip of the other horn. The tip of the thin placental horn is the one more commonly retained. It is important to emphasize that a mare may become just as ill if only a part of the placenta is retained as she will if the entire placenta is retained. Mares with a retained placenta may not exhibit clinical signs of illness in the first few hours after foaling. However, many mares become depressed, off feed and have an elevated body temperature if the placenta has been retained more than 12-24 hours. Rapid bacterial growth within the uterine lumen in the presence of placental membranes may lead to a toxic uterine infection and subsequently laminitis or founder. A retained placenta is potentially life threatening to a mare.

Strategies for management of a retained placenta vary with the duration of retention and the health of the mare. The initial treatment often involves administration of one or two doses of the hormone oxytocin to promote uterine contractions and expulsion of the placenta. If oxytocin therapy is not successful, a large volume of fluid may be infused into the cavity of the retained outer placental membrane to facilitate its release from the uterine wall. If the placenta remains attached, this procedure will at least have removed a significant amount of bacteria, endotoxins and debris from the uterine lumen. The oxytocin and uterine lavage treatments may have to be repeated several times until the placenta is passed.

Manual removal of retained placentas in mares is somewhat controversial. Manual removal has been associated with severe hemorrhage, placental tearing, delayed uterine involution, endometrial damage, intussusception of a uterine horn and uterine prolapse. It may be advantageous to initiate the medical treatments noted above before attempting to manually remove a retained placenta.

Additional medical treatments for mares with a retained placenta may include systemic antibiotics, nonsteroidal anti-inflammatory drugs (i.e. Banamine®), and medications or management practices to prevent laminitis. Therapy should be instituted early, since complications can be severe and life-threatening. The prognosis for mares with retained placenta is generally favorable, but decreases if retention is prolonged or treatment is delayed. Foal-heat breeding is usually avoided in mares with retained placenta or prolonged vaginal discharge. Affected mares may be bred successfully on the subsequent heat cycle.

Horse owners and breeding farm managers are encouraged to examine the placenta after each mare foals. Treatment for retained placenta should be instituted early, since complications can be severe and life threatening. It may be advantageous to administer oxytocin to mares with a history of retained placenta within 1-2 hours after foaling. Mare owners should contact their veterinarian prior to the onset of the foaling season to discuss strategies for early intervention in the event that a retained placenta should occur. The future health of the mare may depend on it.

# Foaling Fundamentals: The Top 10 List

- 1. Due Date** - Gestation Length of horses is approximately 340 days and the due date can be calculated from the ovulation date or last breeding date. Pregnant mares should be vaccinated one month prior to their due date to increase antibody levels in the colostrum. Type of vaccine administered may depend on geographical location, potential exposure and management practices. If the mare has had a Caslick procedure performed, the sutured vulva should be opened approximately 2 weeks prior to the expected foaling date or earlier if needed.
- 2. Milk Calcium** levels increase as the time of foaling approaches. Most mares foal within 48 hours of when milk calcium levels reach 200 ppm. Several commercial test kits are available to help predict when foaling will (or will not) occur.
- 3. Waxing of the Teats** is a sign that foaling will occur in most mares within 24 to 48 hours. Approximately 70 % of mares wax-up prior to foaling and most give birth within 48 hours of waxing. The 'wax' is actually dried colostrum.
- 4. Stage 1 of Labor** lasts for 1-4 hours. Signs of early labor in the mare include frequent episodes of lying down, looking at her flanks, pawing at the ground and patchy sweating. The end of Stage 1 occurs when the mare 'breaks her water' or ruptures the outer placental membrane (chorioallantois) and releases allantoic fluid.
- 5. Stage 2 of Labor** or active labor lasts an average of 17 minutes. The first structure visible at the vulva should be the amnion, a translucent gray membrane. Any delay in active labor may result in decrease foal survival. A key fact is that every 10 minute delay in foaling after 30 minutes of active labor is associated with a 10 % decrease in foal survival.
- 6. Red-bag.** The hallmark of premature separation of the placenta ('red bag') is the appearance of a thick, brick-red, velvety membrane (the chorion) at the vulva during early labor. Red bag should be considered a medical emergency as the oxygen supply to the foal is compromised and veterinary help should be summoned immediately.
- 7. Establishment of an Airway and Stimulation of Breathing** is a top priority when a foal has just been born. The amnion should be removed from the nasal area if it did not break spontaneously during foaling. Respiration may be stimulated by briskly rubbing the newborn foal with a towel and tickling the inside of the nostrils with straw.
- 8. Disinfect the Navel** soon after foaling to help prevent bacterial infections and help seal the umbilical stump. Common disinfectants include dilute Nolvasan, Betadine and Iodine. It is recommended that the navel be dipped 2-3 times per day for the first 2-3 days after birth.
- 9. 1-2-3 Rule.** Foals should stand by one hour, nurse by 2 hours and pass meconium by 3 hours. Ingestion of colostrum, which is rich in antibodies, is critical for early immune protection of the foal. Ideally, a liter or more of good quality colostrum should be ingested by the foal within the first 6-12 hours of life. Antibody levels in the blood of the foal may be checked 24 to 36 hours after birth to determine if adequate transfer of colostrum antibodies has occurred. However, if blood antibody levels are checked earlier (i.e. at 12 hours), oral supplementation with frozen-thawed colostrum or a colostrum substitute can be administered if needed.
- 10. Passage of the Placenta** (Stage 3 of labor) should occur within 3 hours after foaling. Failure to pass the placenta could lead to severe medical conditions in the mare, such as peritonitis and laminitis (founder). Early medical intervention can aid in stimulating passage of the placenta and prevention of subsequent complications.
